### 15. Any other competent business

**Windfarm reps.** TCC is currently in consultations with the developers of Sanquhar II, Lorg, and Troston Loch windfarms. Adriano de Oliveira and Sue Hall will be the contacts for any communications, with Linda McDonad providing cover if required.

**KPT JCBF reps**. These will continue to be Keith and Linda McDonald.

**ANCBC – Annual Local Community Council Grant Application 2019/2020**. A proposal to apply for a £2000 grant from ANCBC by Linda McDonald was seconded by Sue King-Smith. Following a vote on this proposal, there was a unanimous decision by the committee to apply for the grant.

Action: MN to apply for ANCBC grant

**Forestry**. Tilhill have notified immediately affected residents (but not TCC) that they will be upgrading the U401n with passing places, commencing 21 October for 4 days. There are concerns that the road is physically incapable of supporting these 'upgrades'.

Action: SK-S to liaise with Tilhill and D&GC Roads department.

**Cairn Valley Community Transport**. The CVCT initiative would like to include Tynron in their constitution. Tynron would not have to provide a committee member.

Action: LM to reply to CVCT email to accept their offer

**Christmas celebrations**. The dates for the Lights Switch-On will be on 1<sup>st</sup> December, and the Festive Feast will be 8<sup>th</sup> December. More arrangements will be made at a meeting on November 18th.

**Validity of TCC meetings**. It was accepted that with 6 members of TCC there may be occasions when the required 4 elected councillors may not be available for a scheduled meeting to make it quorate. LM had spoken to Hazel Kerr at D&GC who advised:

If it is known ahead of time that a meeting is inquorate, we can change the date so long as the meeting has not been advertised.

One inquorate meeting is OK, but If there are 2 consecutive inquorate meetings then TCC will be dissolved.

TCC can add an extra meeting to ensure that regulations are met (we are required to have 5 regular TCC meetings plus an AGM).

A TCC meeting requires 7 calendar days notification.

**New TCC officers**. Thank you to Linda McDonald who has stepped down as secretary of TCC. There are some new officers in place.

Action: LM to circulate Grapevine with details of TCC members and new officers.

**Retiring councillor.** George Freeborn has retired from TCC after many years service. George was instrumental in the establishment of Community Councils in Scotland, and his many years of service have been of huge benefit to local communities, and Tynron in particular. The current TCC would like to thank George for his hard work on behalf of the Community, and hope he enjoys his retirement!
