5. Secretary's report

Volunteer & Activist Conference

6. Local planning matters

7. Update on timber traffic and forestry issues

Scottish Woodlands (SW) have taken over Tilhill forestry activities in Shinnel Glen. SW will ensure Tilhill make good any outstanding repairs.

Action: MN to provide SKS with outstanding repairs

SW will use the same hauliers as Tilhill and so all drivers will be aware of speed and time restrictions in place.

8. JCBF and KPT updates

At the date of this meeting there had been no response to the suggestions for a clear arrangement of funds following any potential wind-up of JCBF.

LM/KL had raised the issues of limiting community donations to 50% of funds after ring fencing the ANCBC £2000pa out of accountable funds. This has yet to be discussed by Penpont and Keir CCs (at the date of this meeting).

The JCBF have agreed to fund the KPT Hub for 12 months.

The Penpont-Thornhill path is still progressing.

The hydro plant continues to generate electricity and funds for the community. Community volunteers have helped with tree planting and landscaping at the hydro.

The KPT 's Hub Café will open in the next few months.

Funding for CHAT (the group developing the Hub and café) has been granted by the JCBF SKS will be involved in preparing and reporting on a community action plan.

9. Recycling and new bins updates

All of Tynron residences now have the new recycling bins. The bins in the Hall carpark are locked to stop fly tipping. The issue of glass recycling bins has been held over until the next meeting.

10. Windfarm updates

Sanquhar II

At a DPEA meeting held by Zoom on 20 April, a Public Inquiry will be held in October 2021. This will be either by Zoom or in person.

Six CCs have joined forces to be represented by Stop Sanguhar II (SS2), including Tynron.

SS2 have raised concerns about the possible impacts of Sanquhar II windfarm on provate water supplies at Shinnelhead and Polskeoch.

CWL will provide further Additional Information regarding the impact of turbines on the view from more view points.

Euchanhead

60 letters of objection have been received and 1 letter of support

SEPA and Glasgow Prestwick Airport have objected; NatureScot (previously SNH) are concerned about visual impacts; Tynron, Glencairn and Carsphairn CCs have objected. There had been no response from D&GC at the date of this meeting.

11. Roads and potholes in Tynron

SKS has been in touch with DGC regarding the state of the roads in Tynron.

12. AOCB

MN raised the issue of affordable housing in Tynron. Important issues for the selection of a site would be likelihood of planning permission being granted, access to utilities, and access to the site. It was decided that a community open meeting(s) should be held to discuss this issue, held in accordance with

Covid restrictions in place at the time. Fliers and Grapevine communications should be circulated in the Tynron community to keep people informed of developments.
